Terms and Conditions

Working Hours

This quotation has been based on the project being undertaken during our normal working hours of 7.00am to 3.30pm, Monday to Friday.

Quote Terms

This quotation is valid for Ninety (90) days from date of issue.

Invoice Terms

Payment Terms are Thirty (30) days from invoice date.

Payment Terms

We may require progress payments throughout the duration of the project. If required, the specific details and milestones for these progress payments will be outlined in writing, and mutually agreed upon by all parties involved.

Access

Should access be required via a neighbouring property, we will require you to make the appropriate arrangements.

Unsafe Substrate

Where it is suspected that lead or asbestos exists, we would expect to be notified by the client. Where this is confirmed, we will nominate our course of action accordingly. Should we be awarded the work without prior confirmation, then it will be assumed that there are no unsafe substrates on site. If our site operatives then suspect otherwise, it is the responsibility of the client to carry out tests to confirm the composition of the substrate.

Parking

Unless previously advised, we will assume that parking is available for our painting crew, provided free of charge.

Amenities

Unless previously advised, we will assume that amenities (ie: toilets) will be accessible for our workers for the duration of the project. Please advise us if site toilets are unavailable to enable us to make alternative arrangements.

Dangerous Structures

Should a structure (such as a pergola, awning, or similar) be identified and considered unsafe to carry out work from, any repairs or remedial work will need to be undertaken by the owners prior to our painters completing that portion of the work. Unless otherwise noted, we have not made any provision for this repair or remedial works in our quoted Scope of Works.

Water Ingress

Perrott Painting have assumed that any known water issues will be rectified prior to painting. If water ingress issues become apparent after painting, Perrott Painting accepts no responsibility for water damage to the substrate or the newly applied coatings.





Health and Safety

Cm3

Cm3 is Australia's leading online Contractor OHS/WHS prequalification system. Cm3 addresses the need for contractors to demonstrate health and safety management capabilities and this is reviewed and assessed on an annual basis.



Perrott Painting has been accredited with Cm3 since January 2015 and was achieved after an extensive assessment of our company's Occupational Health & Safety policies and procedures.

This accreditation recognises our company's ongoing work and dedication to maintaining and improving on our internal OH&S systems.

ADVANCED SAFETY SYSTEMS AUSTRALIA ("ASSA")

ASSA provides Perrott Painting with the support and information needed to maintain our OH&S policies and procedures. Perrott Painting have been affiliated with ASSA since 2014 and we rely on them to keep us up to date with new legislations affecting the health and safety of our industry.

ASSA also provides assistance with our environmental policies and obligations to ensure we have the correct processes in place to minimize the impact on the environment from our business.



TRADE LICENCING

Perrott Painting currently has a workforce of between 45 – 50 qualified, registered painters who are all professionally led and supervised on the job by some of Perth's most experienced tradesmen. We have 4 senior Supervisors, some of whom have worked for Perrott Painting for in excess of 15-20 years. All of our painters hold a White Card and many of them hold High Risk Licences for EWP and Scaffolding and are also trained for Working at Heights. All of our painters hold current Police Clearances.



SAFETY DATA SHEETS

A Safety Data Sheet (SDS), previously called a Material Safety Data Sheet (MSDS), is a document prepared by the manufacturer that details information with respect to the physical and chemical properties of a product.

Many of the solvents and coatings we use have a safety data sheet which can be made available, on request.

COMMITMENT TO JOB SAFETY

Perrott Painting issues a *Job Safety Pack* to the Leading Hand/Supervisor at the commencement of every job. These packs include safety checklists, our JSA (Job Safety Analysis) forms to report incidents or hazards and other relevant job forms. The paperwork in these packs are completed, signed and returned to the office on completion of every job.

Safe Work Method Statement (SWMS) can also be supplied, if required, for more specific tasks.

All of our safety forms, checklists, SWMS, policies and procedures are reviewed annually to ensure accuracy, relevance and to maintain them to the highest standard.

Perrott Painting recognises our moral and legal responsibility to ensure that our activities, products and services do not place the natural environment or the local community at risk of damage or harm.






Envirosolutions

Quality Control


Independent consultants are expensive and if you've engaged a quality painter to carry out your painting their value is limited to providing peace of mind.

- Date, time and site details
- Records of all products used and where.
